## Hazard Description:

On or about December 6, 2012, at approximately 4:00 am, blood was leaking from a package onto the D-89 belt and on mail on the belt, located in Plant Priority Unit on the 2nd floor of the Oakland Processing & Distribution Plant. This was brought to the attention of Tour 1 supervisor Preet Singh by the employees who were working on the belt. Supervisor Singh allegedly removed the package from the belt without contacting the HAZMAT team or having the employees leave the area. In fact, he instructed them to continue to work on the belt. On January 31, 2013, at approximately 7:20 pm, while working on DBCS 43, located in the Plant on the 3rd floor, employee Magalie Borrero was pricked on the hand by a syringe needle and taken to the hospital for medical treatment. Allegedly, the needle was removed from the area by Manager of Distribution Operation Chung Louie and not taken to hospital with Ms. Borrero for inspection.
