### OAKLAND CUSTODIANS RECEIVE WINDFALL

### \$1.3 MILLION DOLLAR PAYOUT

n pre-arbitration grievance settlement MA-361-15 / F10T-4F-C 15390422. Management agreed to pay a total of \$1.3 million dollars to all custodial groups and levels, including material handlers.

The Oakland Local APWU alleged that Management did not work the required custodial work hours for all custodial groups and levels at the proper staffing level during fiscal year 2015, in accordance with their MS-47 Housekeeping Manual, dated 6/1/83 TL-3 and Gamser award.

Ninety-five career custodial employees of all groups and levels have received up to \$12 thousand dollars each in payouts



and eleven **PSE** custodial em-

ployees have received up to \$9 thousand dollars each in payouts. In August 2018, the remaining \$300 thousand will be distributed to the employees identified by the Oakland Local APWU in grievance MA -360-15 / F10T-4F-C 15391078.



**Remembering President Emeritus William Burrus** 12/13/36 - 5/19/18



William "Bill" Burrus served as elected National President of the APWU, AFL-CIO from 2001-2010. He was the first African-American to be elected president of any national labor union in direct balloting by the membership. Prior to his assuming the presidency, he served as Executive Vice-President for 21 years, working alongside of legendary APWU President, Moe Biller.


